## SECTION 1 - THE SCHEDULE

### CONTINUATION TO SF-1449 19NP-4020-Q-2355 PRICES, BLOCK 23

#### 1. PERFORMANCE WORK STATEMENT

- This solicitation is for mobile (or cellular) telephone services.
  - The U.S. Embassy Kathmandu requires for an estimated 550 official cell phone lines – this number may fluctuate +/- due to current staffing and needs.
- 1.1 The service provider (hereby known as the “Contractor”) shall provide complete mobile telephones services, that will include as a minimum:
- Mobile Telephone Service -75 percent geographical coverage in Nepal and greater within the Kathmandu Valley.
  - Domestic and international calling and receiving - International calls, international roaming, and domestic and international SMS messaging.
  - 24-hour customer service. “One Window Service” - Appoint a corporate manager specifically to handle the U.S. Embassy Kathmandu account.
  - Customer care office within 500-meter radius from the U.S. Embassy Kathmandu.
  - Invoicing on a monthly basis, that includes detailed statements and billing of all charges for individual lines/SIM cards.
  - Data package as requested by the embassy for its employees.
  - Closed User Groups (CUG).
  - Ability to track the International Mobile Equipment Identity (IMEI) of lost or stolen cell phone(s).
  - Unlimited credit limit (i.e., no disconnection of service).
  - Keep the Embassy informed of new packages, increased services, etc.
  - No charge to disconnect, and/or replace bad, lost, or stolen SIM cards at no extra cost.
  - Ability to add additional data upon request of the U.S. Embassy from this negotiated package.
  - Inform U.S. Embassy Kathmandu in advance of any scheduled outages and estimated periods of loss of service for these and any unscheduled outages. Outages shall not be over 12 hours in duration and need to be explained/justified.
  - Accept only an authorized approval in writing from U.S. Embassy Kathmandu start a new service or to suspend a mobile phone package, and/or to add additional services, or an alternate package, for an existing account.
  - At no time can the negotiated package be changed, transferred (change of ownership), or enabled and/or disabled in part, or in whole, without express written authorization from the U.S. Embassy Kathmandu.

- Additionally, the Contractor shall ensure the connection through its network is at its premium level. Network problems shall be remedied immediately, and the Contracting Officer Representative (COR) must be immediately informed of any problems and their resolutions.

## 1.2 CALLS WITHIN NEPAL

- The Contractor shall ensure, on a 24-hour basis, at least 90 percent network coverage in and around the greater city limits of Kathmandu Valley, with special consideration to all urban areas and main traffic routes. The Contractor must guarantee a minimum of 75 percent geographical coverage in the rest of Nepal.

## 1.3 INTERNATIONAL CALLS

- The Contractor shall ensure, on a 24-hour basis, international connectivity to and from any/all countries from both within Nepal and while in roaming status.

## 1.4 INTERNATIONAL ROAMING

- The Contractor shall provide as extensive international roaming connectivity as possible, with the special interest of the U.S. Embassy Kathmandu for roaming within all Europe, Qatar, UAE, Thailand, China, Singapore, Malaysia, Australia, India, Japan, South Korea, and the USA.

## 1.5 SMS MESSAGING

- The Contractor shall provide access at any time to SMS messaging whether in Nepal or outside the country's borders.

## 1.6 CUSTOMER SERVICE

- The Contractor shall provide technical support for setting up roaming and other features that are included in the service package. The customer service will provide answers to questions on features of the services, provide number changes, replace lost or stolen SIM cards, answer billing questions, and any/all other matters concerning the mobile telephone services through the assigned Contractor's Corporate Manager.

## 1.7 DETAILED BILLING

1.7.1 The Contractor shall provide a monthly breakdown of charges and calls made by individual numbers whether the service is a one fee for all services type package or itemized costs for every call and/or service provided. The breakdown shall clearly show:

- Called Number
- Time and Date of the Call
- Duration of the Call
- Cost of call
- Cost of other services and/or fees
- Total fee per person/SIM card
- Total costs of all persons/SIM cards

1.7.2 The monthly lists of calls made shall be forwarded to the Contracting Officer's Representative (COR) at the end of each billing period (the Embassy's preferred billing periods are complete months). All invoices will be provided by the middle of the subsequent month for the month immediately preceding the invoice. All invoice will state that they are invoices, not statements, and be sent to:

## 2. INVOICING

- The Contractor shall submit monthly invoices to the Finance Section of the Embassy per the address given in 1.7.2. A proper invoice must, at a minimum, include the following information:
  - Contractor's name and address of corporate offices.  
Invoice Date.
  - Service Period.  
Contract Number.
  - Page x of y number for each page, with x equaling the individual page number and y equaling the total pages of the invoice.
  - An invoice summary showing a listing of the total of each SIM card number and the charges associated with that number, and a total amount for the invoice.
  - A listed of all calls, with the details of each call, made from each SIM number.
  - The prompt payment discount and when it is due, if applicable.
  - A Point of Contact (name, title, phone number, and address) to call if there are any questions or concern about the invoice(s).

Note: SIM numbers should equate to the telephone number of the individual SIM cards.

If an invoice does not contain, at a minimum, the above information, the U.S. Embassy reserves the right to reject the invoice as improper and return it to the Contractor within 15 calendars days. The Contractor must then submit a proper invoice.

The prompt payment period (30 days) will commence when a proper invoice is received from the Contractor.

Payment shall be made in local currency by Electronic Funds Transfer (EFT) within 30 days after receipt of the proper invoice.

## 3. KEY PERSONNEL

3.1 The Corporate Manager must be able to read, write, and speak in both English and Nepali. All communications with the Embassy shall be conducted in English, and any protests, concerns, issues, etc., need to be expressed clearly in English. The Contractor will assign the following person, and his contact information, to the following personnel with the following contact information:

3.2 During the first 90 days of performance, the Contractor shall make no substitutions of key personnel unless the substitution is required due to illness, death, or termination of employment.

3.3 The Contracting Officer shall be notified in writing of any changes to the key personnel in advance if possible, if advance notice isn't possible, notice will be given within 15 calendar days after the occurrence of the replacement.

3.4 After the first 90 days of performance, the Contractor may substitute a key person if the Contractor determines that it is necessary.

3.5 The Contractor shall provide an explanation of the circumstances requiring the change of personnel notification. A complete resume for the substitute is requested to be provided upon notice that the individual will become, or is, the Embassy's representative. The proposed substitute shall be able to respond to both Nepali and English written and verbal communications.

3.6 The Contracting Officer will notify the Contractor of any difficulties the Embassy has with the assigned representative. The Contractor will work with the Embassy and the individual assigned to be the Key Personnel to overcome any issues, or to change assigned contractor personnel in order to ensure the communications and services provided to the Embassy are as efficacious as possible.

## 4. PERMITS

Without additional cost to the U.S. Embassy Kathmandu, the Contractor shall obtain all permits, licenses, and appointments required for the work under this contract. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable laws in Nepal.

## 5. U.S. EMBASSY KATHMANDU FURNISHED PROPERTY

The Embassy will furnish all cellular telephones for its personnel.

## 6. CONTRACTOR FURNISHED PROPERTY

The Contractor shall provide fully functional SIM cards, and appropriate Security PIN & PUK codes for the sim cards for all existing official cell phones (Approximately 550).

## 7. ADDITION OF NEW LINES

The Contractor will provide a fully functional SIM card and appropriate security codes to the COR within 4 business hours (Monday thru Friday, 8:00 AM to 5:00 PM, local time, excluding a list of holidays to provided separately). The Contractor will adjust the charges accordingly.

## 8. NON-OFFICIAL LINES

This Contract is valid only for official U.S. Embassy Kathmandu's needs and does not include any non-official lines.

## 9. DISCLOSURE OF INFORMATION

Any information made available to the Contractor by the U.S. Embassy Kathmandu shall be used only for the purpose of carrying out the provisions of this contract and shall not be divulged or made known in any manner to any person except as may be necessary in the performance of the contract. Any information associated with the SIM cards issued to the Embassy shall not be divulged to entities outside of the providing company.

## 10. TECHNOLOGICAL REFRESHMENT

After contract award, the U.S. Embassy Kathmandu may, pursuant to FAR clause 52.212-4 - Contract Terms and Conditions –Commercial Items, paragraph (c), Changes, request changes within the scope of the contract. These changes may be required to improve performance or react to changes in technology.

The Contractor may propose for the U.S. Embassy Kathmandu's technological refreshment, substitutions or additions for any provided services that may become available as a result of technological improvements. The U.S. Embassy Kathmandu may, at any time during the term of this contract or any extensions thereof, modify the contract to acquire services, which may require replacement of SIM cards, and/or technological improvements/enhancements to services which are similar to those under the contract and that the Contractor has, or has not, formally announced for marketing purposes. This action is considered to be within the scope of the contract. At the option, a demonstration of the substitute service may be required. The U.S. Embassy Kathmandu is under no obligation to modify the contract in response to the proposed additions or substitutions.

Such substitutions or additions may include any part of, or all updates and/or technological improvements/enhancements to services which may require replacement of SIM cards and service(s) provided that the following conditions are met and substantiated by documentation in the technological refreshment proposal:

The proposed services shall meet all of the technical specifications of this document and conform to the terms and conditions cited in the contract.

The proposal shall discuss the impact on hardware, services, and delivery schedules. The cost of the changes not specifically addressed in the proposal shall be borne entirely by the Contractor.

Contractor has the right to withdraw, in whole or in part, any technological refreshment proposal prior to acceptance by the U.S. Embassy Kathmandu. Contractor will use commercially reasonable efforts to ensure that prices for substitutions or additions are comparable to replaced or discontinued services. If a technological refreshment proposal is accepted and made a part of this contract, an equitable adjustment, increasing or decreasing the contract price, may be required and any other affected provisions of this contract shall be made in accordance with FAR clause 52.212-4, paragraph (c), Changes, and other applicable clauses of the contract.

## 11. DELIVERY ORDERS

The Contracting Officer will issue delivery/cancellation orders for any services requested, or cancellations requested, from the Contractor.

## 12. CUSTOMER SERVICE CENTERS

The Contractor should have a customer care office within a 500-meter radius of the U.S. Embassy Kathmandu compound. The customer care office will be able to provide full-service technical support to Embassy staff.

## 13. SURVIVABILITY AND RECOVERY

The Contractor shall have a plan and equipment in place for a working system of network survivability in case of emergencies and serious disasters. The Contractor will also have a recovery plan in place to deal with such situations.

### QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

The purpose of this plan is to provide an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the U.S. Embassy Kathmandu, is responsible for management and quality control to meet the terms of the contract. The role of the U.S. Embassy Kathmandu is to monitor quality and ensure contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
