Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation”, means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except.

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Contractor shall provide a manpower and equipment details capable of cleaning **1015000** Liters of water tanks. Awarded vendor should have enough manpower as required by US embassy to carry out this work.

Work to be done by awarded contractor as below:

Underground water tank (cemented - masonry)

Before starting the work, Contractor needs to provide safety briefing on confined space entry to their workers on daily basis to ensure that safety procedures is followed and also ensure that the personnel coming to work should wear mask covering the mouth and nose.

1. Remove infected water from tank by pumping out remaining water to nearest storm drain line AND INSPECT THE HATCH AND ENTRY LADDER FOR INTEGRITY AND SAFE ENTRY.
2. Contactor should have adequate lighting device to make sure that the tank sediment is visible during the entire cleaning process.
3. When personnel are working within a tank all "Confined Space" safety measures must be applied.

During the proposal submission, bidder must submit detail **Safety Plan for Confined Space Entry** for working inside the Water Reservoir Tank that will also address Emergency Action Plan for unforeseen accidents that can occur inside the tank.

- Provide technical specification, make and Photos of Air Blowers, quantity that will be used during tank cleaning.
- Provide technical specification, capacity, make and Photos of Tripod, quantity that will be used during tank cleaning.
- Provide quantity of Fall Harness kit.

Contractor must provide required Personal Protective Equipment (PPEs) including Fall Harness/Safety Belt to each employee working inside the tank.

Contractor must provide pre-job training to all their employees. They must know contractor's Safety Plan and hazards associated with working inside the tank.

Contractor shall refer to attached documents while preparing **Safety Plan for * * * Confined Space Entry** (see Section 3: Attachments)

- OSHA's Confined Spaces
- DoS/OBO/SHEM's Confined Space Program Procedures
- Confined Space Entry Permit for Post Approved Confined Space (PACS)

Contractor shall understand how to calculate the Pre-Entry Ventilation Time by using below equation.

*Variable Pre-Entry Ventilation Time Calculation:

The following equation (developed by a major communications company in the U.S. for entry into utility manholes) can be used to determine the pre-entry ventilation time for the particular PACS to be entered: $T = 7.5 V/C$

where,

T = ventilation time in minutes

V = estimated volume of the space in cubic feet (ft³) – do not enter the space to calculate, and

C = effective blower capacity in cubic feet per minute (CFM) – effective blower capacity is the actual quantity of air (CFM) delivered at the end of the flexible duct connected to the blower. If no ductwork is connected, then this is the quantity of air delivered at the outlet of the blower.

During Entry Ventilation: The ventilator must be left operating and ventilating the PACS during the entire time that someone is inside the space.

4. Clean the tank interior. Remove remaining sediments and sludge with submersible pump to eliminate all dirt and sediments settled in the floor of the tank. The sediment that will come out from the water tank has to be cleared by contractor and the contractor is responsible to take the sediment out of the site and not throw it in the sanitary drainage system.
5. Inspect tanks floors and walls. big flashlight for possible cracks, seepage points and any other abnormalities.
6. Report any deteriorated structural or coating of water tank to the COR/GTM
7. Manually clean all parts of the tank with wire brush, cloths and fresh water and remove all resulting residuals.
8. Clean the cover and frame of the water tank with clean water, if found damaged, report it to the COR/GTM
9. Rinse the interior walls and floor with fresh water and any remaining residue.
10. Empty the tank again and remove water after cleaning is completed
11. Mop the floor and make it dry
12. Inspect the suction pipes in the tank and recommend to COR/GTM if it is required for replacement.
13. Add 700 milliliters of sodium hypochlorite (Liquid chlorine) per 3785 liters of the volume in the tank prior to filling the tank with water to produce a 10mg/l (ppm) chlorine concentration. Facilities personnel will ensure testing on site that the level of chlorine in the tank is 10 ppm. If the level of chlorine is less than 10 ppm contractor has to add chlorine until it reaches 10 ppm

14. Contractor should provide Safety data sheet (SDS) for chlorine to be used for tank sanitizing.
15. Keep the chlorinated water for 12 hours and pump the chlorinated water out in the drainage system.
16. Facilities will refill the fresh water in the underground tank and place the tank back in service. In presence of US Embassy water treatment staff contractor will take a sample from first point of entry and last point of entry for analysis in an approved city-based lab.
17. Facilities personnel will check for free chlorine level in - house after cleaning is completed and the tank fill with fresh water to ensure that the chlorine level in the system is 0.2 ppm
18. Contractors should maintain proper housekeeping (Keep clean all the area before leaving the site after work is completed).
19. Make sure to cover the tanks properly, confirming proper seal.
20. Report of water from lab to be submitted to the COR.

Parameters of water to be tested after tank cleaning:

1. pH
2. Turbidity
3. Iron
4. Total Alkalinity
5. Lead
6. Arsenic
7. Manganese
8. Total Coliform

Tank cleaning plan: The following requirements shall be incorporated into the Contractor's water tank cleaning Plan and followed in the field. The plan shall include, but shall not be limited to, a discussion of the following:

- Description of tank cleaning methods and procedures, including any temporary air used during the entire tank cleaning works.
- Time required to clean the underground tank per liter.
- Description of quality control procedures to be used for placement of air blower while work is carried out in the underground tank.
- Description of contamination prevention in the tank and decontamination procedures.
- Description of specific methods to be employed to disperse the water in the tank before it is cleaned.

Contractor technical qualification and submission requirements:

The Contractor shall provide the following technical information when presenting the Bid Package to demonstrate his capacity to do the work and this information will be evaluated in the Bid Review Process by the Contracting Officer.

The minimum necessary information will be:

- Provide list of equipment available to perform multiple tank cleaning in a day.
- Numbers of trained manpower that the contractor can provide in a day.

- Contractor capacity to clean water tank simultaneously based on available manpower and equipment.
- Safety Plan for Confined Space Entry
- Comply with all the Contractual legal and administrative requirements outlined in the bid package provided by the Embassy contracting office such as contractor's general information, capacity to provide Liability Insurance as detailed in the package.
- Work Schedule & Working Methodology: The contractor shall submit work schedule and commencement copy alongside the bid package for the execution of work and working methodology intended for this construction process.

PROJECT SCHEDULE

- Contractor should provide proposed work schedule and time frame to Embassy during submission of proposal.
- Work hours will be from 08:00am to 17:00pm, Monday through Friday at different operating leased houses.

SELECTION CRITERIA

- Contractors will be selected based upon their prior work experiences in water tank cleaning works (please submit list of clients for water tank cleaning only), cost estimates, availability of sufficient tools and equipment's and technical personnel to manage project and or specialty work.

PAYMENT PROCESS

- Contractors will be paid according to the percentage of work completed on timely basis upon submission of the bill. US government will not provide advance payment as well as material in site requests.
- Payment will be made 3-4 weeks after the submission of the bill. VAT shall be charged as applicable.

GENERAL SPECIFICATION OF WORKS:

Once contractor receives and accepts awarded contract, contractor will furnish a within seven (7) days from issue of signed contract.

- Detailed working schedule
- List of names of all workers identified by contractor requiring site access.
- List of all vehicle type, year, and license numbers that will requiring site access.
- Contractor shall furnish all construction materials and labor to perform and complete work.
- Contractor is always required to keep work site neat and presentable condition and, at his own cost
- Contractor must visit the site personally and prepare technical specifications and drawings for all work that are included in the project.
- Contractor shall verify all measurements, surface areas, and material specifications prior to providing a proposed work schedule and timeline to Embassy for approval.
- Contractor shall be responsible for removal and disposal of all construction debris.
- Contractor will provide adequate number and size of waste receptacles and other cleaning supplies.
- Contractor is responsible for site restoration and damaged due to work.

Contractor will provide finish surface protection.

Final inspection will be held with the COR and the Contractor representative assigned to inspect quality and completion prior to final customer acceptance and approvals.

SAFETY:

COR or GTM will ensure that all equipment used during the project is in safe operating condition.

COR or GTM reserves the right to stop the work if any unsafe contractor conditions are observed or encountered.

Safety rules while working inside water tanks

- Possible Hazards: Oxygen deficiency from rusting metal, decay of organic matter, poor ventilation; engulfment by water, and electrocution.
- Contractor must have following materials before working inside the water tank:
 - Ladder
 - Flash lights
 - PPE: Full body fall harness/safety belt with lanyard, rubber gloves, rain boots, etc.

- Cleaning materials and bucket etc.
- Sump Pump
- Extension cable drum
- Portable ventilation blower
- Tripod with lifting mechanism
- High pressure washer.
- Use ventilation equipment, like portable ventilation blower, before entry into water tank. Ventilate for at least half an hour before entry and continue ventilation during entry.
- Use ladder to enter/exit the water tank.
- Contractor must wear rain boots while entering the tank. Bare foot is not allowed.
- Sump pump should always be connected to power outlet or extension cable drum with 10mA GFCI/ELCB to prevent any electrocution to workers inside the tank.
- All electrical devices must have ground cables installed. Cables should be free from cuts and defects.
- There should be an attendant present outside the tank while cleaning work is ongoing.
- Personnel working on a roof, without any railing or fall protection, must wear a safety belt/full body harness along with a lanyard.
- Contractor should submit a written emergency plan to rescue a person trapped inside a water tank.
- Contractor must fill and submit Confined Space Entry Permit before entering a water tank in each residence. (see Section 2: Attachments)

Other Safety Rules and Regulations:

- i. The Contractor shall be responsible for conducting the work in a manner that ensures the safety of employees and visitors at the US Embassy, and the Contractor's employees.
- ii. The Contractor shall be solely responsible for risk assessments, managing health, and safety issues associated with this project.
- iii. The contractor must document in the bid for work how the hazard controls will be implemented and maintained during the project.
- iv. Contractor shall be responsible for any mishaps, injuries or accidents which occur during the project.
- v. Any mishaps and near misses involving contractor's employees must be reported to the COR and FM/OSHO or A-OSHO within 24 hours.
- vi. Based on hazard assessments, Contractors shall provide or afford each affected employee personal protective equipment (PPE) that will protect the employee from hazards. At a minimum PPE shall consist of safety glasses and/or goggles for eye protection, hard hats for head protection, and closed toe shoes. Closed shoes with steel toe are mandatory for employees using power actuated tools like jack hammer, pick for excavation, axe for cutting trees, and for work that requires lifting heavy materials. Sandals or athletic shoes are not acceptable. PPE such as gloves, dust masks, ear buds, and face shield are recommended. These items must be provided at

- the Contractor's expense. All contractor personnel shall wear hard hats, safety glasses, ear-plugs, gloves, close-toes shoes and any other Personal Protection Equipment deemed necessary by the COR and Facility Manager/OSHA or A-OSHA.
- vii. Workers may use discretion if they feel unsafe in using the equipment in a hostile environment.
 - viii. Any worker at an elevated location above 1.8 meters (6 feet), with the exception of a portable ladder, must be provided and utilize a safety harness with lanyard. These items must be in good condition and free from cuts and damages.
 - ix. Scaffoldings should be provided by Contractors for working at heights where ladder use is unsafe. Fall harness should also be provided.
 - x. Welders must have proper PPE: welding goggles/mask, leather gloves, apron or welding jacket that is fire rated. Dedicated fire extinguisher should be on the vicinity of work site. Fire curtain should be used not to expose welding sparks to others.
 - xi. All electrical equipment such as drilling machine, welding machine, portable grinder, power strips and electrical extension cords must be in good working condition, properly grounded and be free from any cuts/defects on the insulation cover. Three pin plugs should be used instead of live wire while plugging on the power outlets.
 - xii. Use wooden or fiber ladders instead of metal ladders while working on electricity.
 - xiii. Contractor shall keep the site clean and organized on daily basis.
 - xiv. The COR or GTM reserves the right to stop the work if any unsafe contractor conditions are observed or encountered. The Embassy Escort may temporarily stop work for any unsafe action.
 - xv. Contractor employee should attend mandatory safety briefing and training provided by the US Embassy Safety team before starting the project.
 - xvi. The Contractor must have a competent person on-site for inspection of equipment, training workers in the safe use of equipment and the recognition of hazards related to their use, supervision, and identifying and correcting unsafe work practices for high hazard work.
 - xvii. Safety Training:
 - a. Provide specific training to supervisory personnel and all craft workers of the Contractor and subcontractors in proper use and care of specific personal protective gear, equipment, and clothing.
 - b. Contractor and subcontractor employees shall be trained and supervised by qualified persons to safely and confidently perform and recognize hazardous work operations and work performed with hazardous conditions to which they have been assigned.
 - c. Contractor shall conduct safety meeting on periodic basis as required before starting work at high hazard area.

SECURITY:

- The warranty of contractor work shall continue for a period of one year from the date of customer final acceptance of the work.
- All product warranties greater than one year shall be conveyed to customer.
- Contractor shall be responsible to correct any and all faults or defects which may occur within a year from the date of final acceptance of the work.
- Contractor shall repair or replace low quality work that does not meet industry standards.
- The contractor shall bear all the cost to fix the repairing work during the warranty period.

Subpart 636.5 - Contract Clauses

636.513 Accident prevention.

(a) In accordance with a class deviation approved by the Procurement Executive, contracting officers at overseas contracting activities shall insert DOSAR 652.236-70, Accident Prevention, in lieu of FAR clause 52.236-13 when awarding construction contracts. The contracting officer shall confer with OBO/OM/SHM if there are any questions on any factors listed in paragraph (4) of the clause, or if the contracting officer has any questions regarding construction safety issues.

652.236-70 Accident Prevention.

As prescribed in 636.513, insert the following clause:

ACCIDENT PREVENTION (APR 2004)

(a) General. The contractor shall provide and maintain work environments and procedures which will safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to contractor operations and activities; avoid interruptions of Government operations and delays in project completion dates; and, control costs in the performance of this contract. For these purposes, the contractor shall:

(1) Provide appropriate safety barricades, signs and signal lights;

(2) Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and,

(3) Ensure that any additional measures the contracting officer determines to be reasonably necessary for this purpose are taken.

(4) For overseas construction projects, the contracting officer shall specify in writing additional requirements regarding safety if the work involves:

(i) Scaffolding;

(ii) Work at heights above two (2) meters;

(iii) Trenching or other excavation greater than one (1) meter in depth;

(iv) Earth moving equipment;

(v) Temporary wiring, use of portable electric tools, or other recognized electrical hazards. Temporary wiring and portable electric tools require the use of a ground fault circuit interrupter (GFCI) in the affected circuits; other electrical hazards may also require the use of a GFCI;

(vi) Work in confined spaces (limited exits, potential for oxygen less than 19.5 percent or combustible atmosphere, potential for solid or liquid engulfment, or other hazards considered to be immediately dangerous to life or health such as water tanks, transformer vaults, sewers, cisterns, etc.);

(vii) Hazardous materials - a material with a physical or health hazard including but not limited to, flammable, explosive, corrosive, toxic, reactive or unstable, or any operations which creates any kind of contamination inside an occupied building such as dust from demolition activities, paints, solvents, etc.; or

(viii) Hazardous noise levels.

(b) Records. The contractor shall maintain an accurate record of exposure data on all accidents incident to work performed under this contract resulting in death, traumatic injury, occupational disease, or damage to or theft of property, materials, supplies, or equipment. The contractor shall report this data in the manner prescribed by the contracting officer.

(c) Subcontracts. The contractor shall be responsible for its subcontractors' compliance with this clause.

(d) Written program. Before commencing work, the contractor shall:

(1) Submit a written plan to the contracting officer for implementing this clause. The plan shall include specific management or technical procedures for effectively controlling hazards associated with the project; and,

(2) Meet with the contracting officer to discuss and develop a mutual understanding relative to administration of the overall safety program.

(e) Notification. The contracting officer shall notify the contractor of any non-compliance with these requirements and the corrective actions required. This notice, when delivered to the contractor or the contractor's representative on site, shall be deemed sufficient notice of the non-compliance and corrective action required. After receiving the notice, the contractor shall immediately take corrective action. If the contractor fails or refuses to promptly take corrective action, the contracting officer may issue an order suspending all or part of the work until satisfactory corrective action has been taken. The contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule on any suspension of work order issued under this clause.
